The Club at Irish Creek has extended the popular “*Friends of the Club*” membership recruiting plan. The plan encourages and financially rewards current club members to bring friends, associates and family into the club. Newly recruited members also receive financial incentives.

**Incentive Plan to Current Club Members and New Golf Members**

- As an incentive, current club members who refer new golf members into the club will receive a **\$40** monthly dues credit for twelve consecutive months for each new golf membership referral. Total monthly dues credits cannot exceed monthly base dues.
- As an incentive, newly referred golf members will receive a **\$40** monthly dues credit for twelve consecutive months. New golf members may refer additional new golf members into the club and receive the appropriate incentives.
- The sponsoring member and the new member must each remain in good standing with the club during the twelve month period in order to receive the monthly incentives. In the event that one member becomes delinquent or resigns during the twelve month period, the remaining member would forfeit the remaining incentives.
- The classifications for all memberships offered within this plan are considered Term. Term memberships may be recalled after five years and only if the club has reached capacity and there is a waiting list to join. Term memberships are non-refundable.
- A new golf member must commit to a minimum of one year active membership to qualify for the promotional offering.
- Current Irish Creek golf members may choose reclassify to any new Term classification as long as they meet qualifications. No incentives apply to transfers of existing memberships. Any transfers would be considered “Term” and would be subject to the term recall procedures.
- Irish Creek members who resign during the 2017/2018 calendar year would not be eligible to rejoin with incentives. Members are encouraged to invite former club members to rejoin the club. Former members must have resigned the club in good standing to be eligible.
- Standard club memberships (non-Term) remain available at standard published rates. Contact Alan Cress – General Manager/Membership for details.

**\*Effective January 1, 2018: 50 additional memberships will be released at this promotional rate.**

## **2018 Term Golf Membership Classifications and Fee Structure**

**Term Golf Family Membership** - Available to primary member, age 35 to 59.

Initiation Fee - \$500

Monthly dues- \$288 (First year with incentives - \$248)

Monthly Range fee- \$15

Monthly dining minimum-\$25.

**Term Senior Golf Membership** – Available to primary member age 60 or older.

Initiation Fee -\$500

Monthly dues - \$247 (First year with incentives - \$207)

Monthly range fee - \$15

Monthly dining minimum -\$20

**Term “Super Senior” Golf Membership** - Available to primary member age 60 or older. Weekday golf privileges only (no weekends or holidays), full club house privileges seven days a week.

Initiation Fee -\$500

Monthly dues -\$206 (First year with incentives - \$166)

Monthly range fee -\$10

Monthly dining minimum -\$20.

**Term Junior Golf Membership**- Available to primary member who remains under the age of 35. Once the Junior member reaches 35 years of age, the monthly dues will revert to current full member status.

Initiation Fee - \$500

Monthly dues - \$247 (First year with incentives - \$207)

Monthly range fee - \$15

Monthly dining minimum -\$25

**Term Non-Resident Golf Membership**- Available to primary member whose primary residence is outside a 20 mile radius of the club address. Business or secondary addresses are not allowable.

Initiation Fee -\$500

Monthly dues -\$206 (First year with incentives - \$166)

Monthly range fee -\$15

Monthly dining minimum -\$25

**Irish Creek Statesman Golf Membership**- Available only to current club members age 75 or older who has maintained an Irish Creek golf membership for at least five consecutive years.

Monthly dues -\$206 (No additional incentive)

No range fee

No dining minimum.

## **2018 Term Social and Dining Membership Classifications and Fee Structure**

**Term Family Social/Sports Membership**- Includes all club amenities except golf.

Initiation Fee - \$300

Monthly dues -\$62 (No additional incentive)

Monthly dining minimum -\$20

**Sponsoring Member and Prospective Golf Member  
Incentive Agreement**

- All prospective members must complete the club membership application process and are subject to the approval procedure.
- The prospective golf member agrees to maintain an active club membership for a minimum of twelve consecutive months. A valid credit card is required and will be held on file in the event of failure to comply.
- As an incentive, the sponsoring club member and the prospective golf member will each receive a \$40 monthly club dues credit for twelve consecutive months. Monthly incentives cannot be split, transferred or deferred.
- If either the sponsoring club member or the prospective golf member should resign or become delinquent during the twelve month promotional period, the remaining member would revert to standard monthly dues at the beginning of following month. Standard monthly dues are subject to change annually.
- The club agrees that the promotional “Term” memberships cannot be recalled for a period of five years from the date below and only then if the club has reached capacity and a waiting list to join the club exists. Term memberships would then be recalled, last in, first out. Term memberships are non-refundable.
